RHA'S EDUCATION INITIATIVES INCLUDED NATURE-BASED PROGRAMMING FOR YOUNG CHILDREN, SCHOOL GROUPS, HIGH SCHOOL STUDENTS, AND ADULTS. PROGRAMS INCLUDED NATURE DAYS AT FAIRVIEW FARM WILDLIFE PRESERVE, WATERSHED UNIVERSITY FOR HIGH SCHOOL STUDENTS, FIELD-BASED ENVIRONMENTAL EDUCATION PROGRAMS, GUIDED KAYAK EXPERIENCES, SERVICE-LEARNING OPPORTUNITIES, AND COMMUNITY EDUCATION EVENTS. WATERSHED TOOLS FOR LOCAL LEADERS SEMINARS AND MUNICIPAL OUTREACH PROGRAMS PROVIDED EDUCATION ON CRITICAL ENVIRONMENTAL TOPICS TO CITIZENS, MUNICIPAL OFFICIALS, AND OTHER DECISION-MAKERS.

POLICY ADVOCACY FOR WATER PROTECTION WAS UNDERTAKEN IN PARTNERSHIP WITH ORGANIZATIONS SUCH AS THE NEW JERSEY COUNCIL OF WATERSHEDS, MUNICIPAL PARTNERS, AND STATEWIDE CONSERVATION ORGANIZATIONS. RHA ADVANCED ADVOCACY RELATED TO WATER SUPPLY RESILIENCE, DROUGHT MANAGEMENT, LAND PRESERVATION, STORMWATER MANAGEMENT, SOURCE WATER PROTECTION, AND NATURAL RESOURCE CONSERVATION. COLLABORATIVE EFFORTS WITH FEDERAL, STATE, COUNTY, MUNICIPAL, AND NONPROFIT PARTNERS ALSO SUPPORTED PLANNING AND IMPLEMENTATION OF RIVER RESTORATION PROJECTS, INCLUDING DAM REMOVAL AND FISH PASSAGE PROJECTS IN THE SOUTH BRANCH WATERSHED.

AS AN ACCREDITED LAND TRUST, RHA ACTIVELY PURSUED THE PRESERVATION OF OPEN SPACE, RIPARIAN AREAS, FORESTS, WETLANDS, AND WILDLIFE HABITAT THROUGHOUT THE HEADWATERS REGION. STEWARDSHIP ACTIVITIES INCLUDED ANNUAL MONITORING OF CONSERVATION EASEMENTS AND RHA-OWNED PRESERVES, BASELINE DOCUMENTATION, LANDOWNER COMMUNICATION, HABITAT MANAGEMENT, AND LONG-TERM PROTECTION OF CONSERVED LANDS. RHA ALSO COLLABORATED WITH THE NEW JERSEY HIGHLANDS COUNCIL, RUTGERS UNIVERSITY WATER RESOURCES PROGRAM, AND THE NEW JERSEY WATER SUPPLY AUTHORITY TO DEVELOP WATERSHED MANAGEMENT PLANS FOR THREE SUBWATERSHEDS IN THE HIGHLANDS REGION.
